JUDGMENT

This action came before the Court for trial by jury on May 14, 2018, in Courtroom 2D, the Honorable Gonzalo P. Curiel, presiding. The Plaintiffs—D.F., a minor, by and through his guardian ad litem, Tashina Amador, individually and as successor in interest to Alexis Fontalvo, deceased; and T.L., a minor, by and through her guardian ad litem, Tashina Amador—were represented by attorneys Lawrence P. Grassini and Marshal J. Shepardson. The remaining Defendants in this case—Sikorsky Aircraft Corporation and

1 United Technologies Corporation—were represented by attorneys Christopher S. Hickey,
2 James W. Hunt, and Jesse F. Ruiz.


3 After presentation of evidence and arguments of counsel, the jury was duly
4 instructed by the Court and the cause was submitted to the jury with directions to return a
5 special verdict. On May 31, 2018, the jury returned a verdict in favor of the Defendants.
6 (ECF No. 329.)

7 NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that:

- 8 1. Judgment is entered in favor of all Defendants;
- 9 2. Plaintiffs D.F., a minor, by and through his guardian ad litem, Tashina
10 Amador, individually and as successor in interest to Alexis Fontalvo, deceased; and T.L.,
11 a minor, by and through her guardian ad litem, Tashina Amador, will recover nothing
12 from Defendants; and
- 13 3. Defendants recover costs from Plaintiffs D.F., a minor, by and through his
14 guardian ad litem, Tashina Amador, individually and as successor in interest to Alexis
15 Fontalvo, deceased; and T.L., a minor, by and through her guardian ad litem, Tashina
16 Amador.

17 This judgment disposes of this action in its entirety as to all parties and all causes
18 of action.
